IT IS HEREBY RESOLVED that the following Ordinance is adopted by the Charlotte County Board of Supervisors:

ORDAINED: Section 70-1 of the Charlotte County Code of Ordinances is hereby amended to provide that the provisions of Sections 46.2-868, 46-2852, and 46-2-862 of the Code of Virginia, 1950, as amended, are hereby a adopted and incorporated in Chapter 70 of the Charlotte County Code of Ordinances by reference and made applicable within the County.

FURTHER ORDAINED: The penalty imposed for the violation of any provision or requirement hereby adopted shall be the penalty imposed for the same offense under the applicable section of the Code of Virginia, 1950, as amended.

FURTHER ORDAINED: All fines imposed and collected for a violation of this Ordinance shall be paid into the Charlotte County Treasury.

EFFECTIVE DATE: This Ordinance shall become effective on April 8, 2014.
