WHEREAS, the POW/MIA flag stands as a powerful symbol of national commitment to America's POW/MIAs

NOW, THEREFORE, BE IT RESOLVED that a ceremony in honor of our POW/MIAs commence at 11:00 AM, September 19, 2014 and that the POW/MIA flag be flown continuously in honor of our POW/MIAs.

Motion was made by Haywood J. Hamlet, seconded by Garland H. Hamlett, Jr. to approve a 2% employee increase for all county employees effective July 1, 2014.
