Motion was made by Nancy R. Carwile, seconded by Warren E. Weston and carried with all other members present and voting yes to re-adopt the current Virginia Statewide Uniform Building Code.

Motion was made by Nancy R. Carwile, seconded by Garland H. Hamlett, Jr. and carried with all other members present and voting yes to adopt the following resolution in support of the Bees for the Future;

WHEREAS, the Virginia Tobacco Region Revitalization Commission Agribusiness Grant Program supports projects that will diversify the long-term Agribusiness economy of Virginia's tobacco region and generate net new income for agricultural producers in the tobacco region; and

WHEREAS, Charlotte County is located in the tobacco region and the loss of tobacco income in the county has resulted in significant increases in other crops including soybeans; and

WHEREAS, as a result of new markets for locally grown produce including the Southside Produce Auction and the Charlotte County Farmers Market at Drakes Branch, produce acreage in the region is also increasing; and

WHEREAS, pollinators, including honeybees, play a major role in crop yields for many crops including soybeans and most fruits and vegetables, and there is growing concern about the wellbeing of the honeybee population due to disease, climate change and the use of pesticides; and

WHEREAS, the Heart of Virginia Beekeepers Association is committed to working with new beekeepers to help establish new hives and boost the local honeybee population;

NOW THEREFORE, BE IT RESOLVED, that the Charlotte County Board of Supervisors does hereby express their support of the "Bees for the Future" agribusiness grant application, and confirms their willingness to partner with the Heart of Virginia Beekeepers Association on the "Bees for the Future" project by serving as project coordinator and fiscal agent.
