Thomas Jones, Sheriff addressed the Board. Mr. Jones stated the State had given a compression raise that took effect February 1, 2019. Mr. Jones requested Board approval to give the noncomp employees the same raise retroactive to February 1, 2019 using funds from the current year's budget. The employees consisted of 3 resource officers and 6 other employees. Mr.

Witt's recommendation was to address this issue at the April 2019 Board meeting and was concurred by all Board Members.

The budget was discussed in detail with emphasis on Capital Improvement Funding, Departmental request, a 3% raise for all full time and part time employees.
